# Town of Needham Board of Selectmen Minutes for June 9, 2009 Needham Town Hall

6:45 p.m. Informal Session:

Residents of Edgewater Drive appeared before the Board of Selectmen to discuss construction issues at 112 Edgewater Drive. Mr. Matthews asked the Town Manager to work with the neighbors in an attempt to reach a resolution to the situation.

7:00 p.m. Call to Order:

A meeting of the Board of Selectmen was convened by Chairman Daniel P. Matthews at 7:00 p.m. Those present were John A. Bulian, Denise C. Garlick, Maurice P. Handel, Gerald A. Wasserman, Town Manager Kate Fitzpatrick, and Recording Secretary Mary Hunt.

7:00 p.m. Public Hearing – NSTAR Petition for Briarwood Circle:

Maureen Carroll, NSTAR representative, appeared before the Board to request permission to install conduit on Briarwood Circle to provide electrical service to 67 Briarwood Circle.

Motion by Mr. Bulian that the Board of Selectmen vote to approve and sign petition from NSTAR to install approximately 13 feet of conduit at pole 366/9 Briarwood Circle, Needham. This work is necessary to provide new overhead/underground electric service at 67 Briarwood Circle.

Second: Maurice Handel. Unanimously approved 5-0.

7:05 p.m. Public Hearing – New All Alcohol License/Manager, and Common Victualler License for Restaurant Pomodoro, Inc. located at 1019 Great Plain Avenue, Kevin Ryan, Manager.

Mr. Matthews opened the public hearing for comment. There was no comment.

Motion by Mr. John Bulian that the Board of Selectmen vote to approve the applications for new All Alcohol and Common Victualler Licenses under the Town of Needham Rules and Regulations Applicable to the Sale of Alcoholic Beverages in Restaurants and Function Rooms with Seating Capacity of Not Less than 100 Persons for Restaurant Pomodoro, Inc. Kevin Ryan, Manager, and forward the approved application to the ABCC for an approval of the liquor license.

Second: Gerald Wasserman. Unanimously approved 5-0.

Mr. Matthews provided a summary of the Town's expectations for establishments serving liquor, and welcomed Mr. Ryan to Needham.

7:05 p.m. Energy Presentation – Performance Contracting

Chip Laffey, Director of Public Facilities Operations, Eileen McHugh, Department of Energy Resources, and Carys Lustig, Administrative Analyst appeared before the Board to provide an overview about Energy Performance Contracting and how its implementation might allow the Town to upgrade its infrastructure and improve the energy efficiency of its buildings by utilizing future energy savings to pay for them now through a guaranteed savings contract. Mr. Laffey noted that the project is at a very preliminary stage.

Mr. Matthews thanked the presenters for their time and effort in putting together an informative and detailed presentation.

### 7:30 p.m. Town Manager Report:

The Town Manager appeared before the Board with three items:

- 1. Ms. Fitzpatrick reminded the Board about the Open Meeting and Conflict of Interest training for board and committee members to be held on June 10, 2009.
- 2. Ms. Fitzpatrick noted that the Needham High School graduation took place on Monday, June 8, 2009 at Memorial Field. Many people in Town are looking forward to the upcoming 4<sup>th</sup> of July events to be held at Memorial Field.
- 3. Ms. Fitzpatrick advised there has been some concern with baseballs flying out of Memorial Field during games. The Town is working to remedy the situation.

## 7:35 p.m. Board Discussion:

The Board of Selectmen reviewed and discussed the proposed goals for FY2010 – FY2011. The Board agreed to set aside prioritizing the goals until the July 21, 2009 meeting, and to focus on specific items that may or may not be addressed within the two-year timeframe.
