A meeting of the Mobility Planning & Coordination Committee was convened by Tim Bulger, Chair. 7:02 p.m. Approve Minutes from October 17, 2024:

Motion by Mr. Handel to approve the meeting minutes from October 17, 2024. Second: Mr. Allen. Approved 5-0-1, with Mr. McCullen abstaining.

7:02 p.m. Bike Plan and Map (Continued):

Mr. Bulger led discussion on the topic of the Bike Plan and Map, basing discussion off of a list of proposed areas for bike lanes based on discussion at the last meeting. The next proposed step is to visualize this list in a map format. Committee members provided feedback about the most effective way to display this information visually, including developing various layers and colors that viewers could toggle between to experience different views, also taking into consideration the Select Board, Police Department, DPW, and the public about what is most helpful to them when using the map. Other municipalities referenced were Brookline and Somerville. Committee members also discussed the challenge of current parking in bike lanes. The Committee also discussed who are the partners in the Town Administration who will support this Committee to enable the infrastructure that is built delivers the safety benefits that are intended, through public information efforts and other strategies.

Other specific topics included suggested bike routes to the High School and Middle School and ensuring consistencies of signs around the Town. This is to ensure that drivers and other operators remain vigilant to signage. Finally, members discussed costs and opportunities for grant funding.
