Heidi Frail presents the different MBTA Articles and letter of support for Town Meeting, explains the difference between the two plans in density and areas showing 1870 in the base compliance plan and 3296 in the neighborhood housing plan.

Rick Putprush mentioned the underlying zoning and how that will change with the lot sizes being as small and the assembly required to build a project in some of the areas,

Adam Block spoke that there are variations depending on the district and it is not a one size fits all, Chestnut Street is proposed at 18 units max per acer while Avery square is 44. This makes sure the community is protected from overbuilding in certain areas and was based in feed back the planning board received.

Bill Day asked why specific areas were or were not included, Heidi explained that some of the land to be included can be outside of the station area and is an existing area and some of the area is existing but can be used in compliance.

Lise Elcock made comments that we can't tweak these plans at this point and that it was a long process to get here, and that the neighborhood plan is a more all encompassing plan.
