<u>Decision: Major Project Site Plan Review No. 2018-09: Dr. Marcia A. Walker d/b/a Rx2Care Clinic, 660 South Street, Needham, MA, Petitioner (Property located at 1498 Highland Avenue, Needham, MA).</u>

Ms. McKnight noted in Section 3.13, it should say the trash receptacles shall be provided if required "by the Board of Health." All agreed. Dr. Marcia Walker, applicant, noted she had asked for 60 days to meet certain conditions but is now requesting 90 days to get everything done. All members agreed.

to grant (1) the requested Major Project Site Plan Review Special Permit under Section 7.4 of the Needham Zoning By-Law; (2) the requested Special Permit under Section 3.2.2 of the By-Law to operate a medical clinic in the Center Business District; (3) the requested Special Permit under Section 3.2.2 of the By-Law for more than one non-residential use on a lot: (4) the requested Special Permit under Section 1.4.6 of the By-Law, if applicable, for alteration or reconstruction of a non-conforming structure; and (5) the requested Special Permit under Section 5.1.1.6 of the By-Law to waive strict adherence with the off-street parking requirements of Section 5.1.2 (required parking) and Section 5.1.3 (parking plan design requirements) of the By-Law.

Upon a motion made by Ms. Grimes, and seconded by Ms. McKnight, it was by the five members present unanimously:

VOTED:

to accept the decision with the 2 changes discussed tonight.
