#### **Agenda Item 1:**

## <u>FastSigns representing CODE Wiz located at 333 Chestnut Street and applying for signage</u>. - Tim Parker

Mr. Parker came before the Board representing CODE Wiz, a franchise moving into 333 Chestnut Street. They are proposing a sign made up of LED internally lit 3D channel letters mounted onto a raceway painted to match. The sign will also contain a digitally printed face graphic, installed on the raceway. The sign is proposed to be 152 inches wide and 34 inches high.

Ms. Robinson thought the sign is too big for the vertical face, it needs to fit into the height of the grey band between the top of the windows and the roof flashing.

Mr. Karan concurred with the Board members regarding reducing the sign. He asked if the sign is to be centered. Mr. Parker said they had to move the sign to the right because of a large tree obstructing the left window.

There was some discussion about the placement of the words in the sign on the façade. He preferred to center the word "CODE" over the window.

Motion to reduce the overall height of the sign so that the height of the uppercase letters is no larger 16 ½ inches and the overall site including the face graphic be reduced proportionally and that the overall width of the site would be centered on the center opening of the three windows by Ms. Robinson.

### **Agenda Item 2:**

# <u>Peter Fallon, Fallon Custom Homes located at 171 Reservoir Street and applying for signage and lighting.</u> - Peter Fallon

Mr. Fallon came before the Board asking to install 3 foot by 15-foot sign on existing brackets at the rear of the building. He would also like to install an exterior light for the signboard.

Mr. Reilly brought to the Board's attention that the original rear sign was never permitted therefore this application needs to be reviewed as new signage not simply replacing an existing properly permitted sign.

Mr. Reilly also pointed out that if a building is visible from Route 128 than the maximum allowable size is 100 sq ft. The sign submitted is too big according to the bylaw and would require relief from the bylaws.

Ms. Robinson said the DRB typically does not allow phone numbers or website information on signs. She does not have a problem with the sign, but she would want the number and website removed.

Mr. Karan asked if the background going to remain white as suggested in the drawings. Mr. Fallon said yes. Mr. Karan said he is worried about the background in terms of how it will look with the contrast of the rusty brackets. He suggested perhaps changing the background color. Mr. Fallon said he plans to clean up the brackets and the rust.

Mr. Reilly said he does not know how long the brackets have been there, he would suggest removing the existing brackets and installing new framing. Mr. Reilly provided some feedback regarding the overall signs, the background color, and the design. He suggested this application be continued to the following meeting.

Mr. Fallon intends to come back before the Board with a new application now that he has this feedback.
