Public Safety and Fire Station #2

- Completion of Fire Station #1 at HQ
- Completion of Dispatch and Microwave Communications System
- Move of NPD and NFD to Temporary Quarters at Hillside
- Demolition of HQ & Fire Station #2
- HQ -Start Phase II foundations
- Fire Station #2 Foundations (Includes hazardous soils removal) and Steel Erection



Sunita L. William Elementary School

- Project complete (more than \$10M under budget)
- Closeout documentation submitted to MSBA for final Audit
- SMART designation received for Solar installation (energy net benefit \$77,000) & LEED Silver Certification received
- Outside Play Area and Walking Trails closed out, Con Comm Certificate of Compliance with DEP and Needham Conservation allowing expanded outside play area during 2020 Pandemic





Rosemary Pool Complex

- Limited Opening in 2018; full opening in 2019
- Water side upgrades and warranty work
 - -Closed out 2-year inspection and Certificate of Compliance with DEP and Needham Conservation

Memorial Park Field House

- Limited Opening for July festivities in 2019, full opening Fall 2019.
- Ongoing warranty work completed, including replacing three non-performing AHU's
- Placement of acoustical sound dampening panels in Trustees Board Room and Multi-purpose room.



Jack Cogswell Building

- Opened in Winter of 2019
- Punchlist competed
- Solar design completed and submitted to Eversource for permit approval
- Weather Station installed
- Con Comm approval, awaiting written confirmation



Recommissioning of all Schools in the District

- Assistance to Building Maintenance Department to recommission all schools due to the COVID-19 Pandemic
- Helped manage testing and balancing of ventilation to confirm adequacy of airflow and constituents of all classroom, office and common spaces
- Extensive cleaning, repairs and adjustments required
- Monitoring, testing and repairs will extend through 2021 school year

Needham High School Expansion




- Opened in Fall of 2018;

- Addition of new public address and bell system for entire school






Ridge Hill Manor House & Garage






Ridge Hill Demolition

- Completed the Demolition Study for Ridge Hill Manor House and Garage
- Study completed November 2020
- To be presented to ATM for funding (\$760,000)



Emery Grover Building Study

- Final report received in June 2020, recommends renovation and expansion of building after review of numerous options
- Full gut renovation of existing building with 50 ft x 100 ft, three-story addition
- Ongoing review by Select Board, Finance Committee, Community Preservation Committee (CPC) and School Committee
- L-shaped addition provides handicapped access to historic building and needed office space with enhanced natural ventilation and lighting to occupants




School Master Plan Study

- Report received November 2020, following year of detailed assessment and review of options
- Study available on the School Department website at <u>http://www.needham.k12.ma.us/departments/business_operations/business_office/enrollment_capital_planning_construction_proj_</u>
- School Committee Recommended (Option D.1):High Rock as Elementary School, Pollard (6-8) Middle School as first accelerated (non-MSBA) project and Mitchell 3-section Elementary School (MSBA) project
- Achieves most rapid solution to elementary and middle school educational and facility issues at the lowest overall cost (\$250M over 7 years, with escalation included)
- Modified Plan allows implementation to begin in May 2021.
- Ongoing review by Select Board, School Committee and Finance Committee


