TOWN OF NEEDHAM - RESIDENTIAL DEMOLITION APPLICATION DETAILS

If you are demolishing a detached garage, shed or pool, please call and speak with an Inspector PRIOR to applying for a permit.

- 1. Log onto ViewPoint Cloud (VPC) and select "Building Department" then "Demolition Permit (Excludes Interior Renovations)".
- 2. Click on "Apply on Line". Please note that only a Construction Supervisor can apply for a Demo Permit.
- 3. Your Demo Application will automatically circulate to the following departments, so no action is required on your part:
 - a. Water
 - b. Sewer
 - c. Fire
 - d. Conservation
- 4. You need to upload a demolition approval letter from:
 - a. Electric Company
 - Gas Company
 If there is no gas to the property, you need a letter from the Gas Company stating that there is no gas on the property.
 - c. HVA Contractor regarding Air Conditioning Condenser Freon Recovery.
- 5. The following are required uploads to your application:
 - a. Current Plot Plan on TOWN OF NEEDHAM PLOT PLAN FORM (www.Needhamma.gov).

 Plot Plan needs to include existing conditions, water/sewer lines, existing topography and existing building(s) footprint(s),
 - b. Proof of Ownership / Quit Claim Deed
 - This is from the Registry of Deeds and cannot say "Not an Official Copy" on it.
 - c. Copy of Notice to Abutters. Abutters are all owners whose property touches yours, those directly across the street and behind you as well as all diagonal properties. If the back of your property abutts the active MBTA Commuter Rail, they need to be notified via Certified
 - d. Completed USPOffice Certified Mail, Green & White Mailing Receipts for all Abutters' Letters.
 - e. Copy of valid CSL License.
 - f. Commonwelath of Massachusetts Workers' Comp Affidavit.
 - g. Certificate of Insurance showing Liability and Workers' Comp coverage (if applicable).

Notes:

- Please fill out one Residential Demolition Permit application per structure, such as a dwelling and a detached garage.
- You need to apply to the Health Division for their approval of your demolition. Please apply online through ViewPoint Cloud ASAP as Health can take longer than the Building Department to process your application.
- → Only a Construction Supervisor may apply for a demo permit.

Completerd US Post Office Certified Green/White Mailing Receipts with Address Listed

Workmens' Comp Affidavit

(Valid HIC is required for Building Permit but not for Demo Permit)
