Scope of Work

This position maintains trees and woody plants to ensure their healthy, safe, and attractive condition including chemical applications, repairing, cabling, fertilizing, watering, pruning, and removal of any dead, diseased or declining trees, or other woody plants.

Essential Job Functions

An employee in this position may be called upon to do any or all of the following essential functions. These examples do not include all of the duties which the employee may be expected to perform. To perform this job successfully, an individual must be able to perform each essential function to satisfaction.

General Tasks:

- Assist in the care, removal and appearance of Town trees; prune, trim, top and fell trees; cut and remove severed tree limbs, dead branches, and related brush; cut trunks and dispose of stumps; and dig, ball, and plant new trees.
- Respond to service calls to evaluate services required; determine Town responsibility for tree removal, trimming, etc. and need for Police safety details; mix insecticides and herbicides; spray trees and brush; and assist in seasonal responsibilities including mowing, leaf and rubbish collection, pool and ice-skating rink maintenance, and general park maintenance.
- Operate bucket truck and aerial equipment, chain saw, chipper, stump cutter, and related equipment; perform related equipment maintenance; set up riggings for safety in performance of job duties; and climb trees.
- Provide assistance to other DPW divisions as required; and assist and monitor outside contractors performing related work for the Town.
- Operate snow plowing, removal, sanding, and salting equipment; provide emergency assistance as needed; respond to inquiries, requests and complaints from residents, contractors, and Town employees; and endeavor to continuously improve services to taxpayers.

Other Job Functions

• Performs related duties as assigned.

Requirements of Work

Extensive technical or specialized training such as that which would be acquired by an Associate's Degree or as demonstrated through attainment of the ISA Certified Arborist credential, supplemented by at least 4 years of relevant. Valid Massachusetts Driver's License; CDL; Class C Hoist Engineer; Pesticide Application, and appropriate endorsements.

Knowledge, Ability, and Skill

In addition to the requirements of work, the individual should also have the following knowledge, ability, and skill:

Physical Demands
